Job Purpose

Responsible for surveying sites prior to and, where required, during active site operations to locate, identify, mark up and record all underground services, hazards, and GS6 overhead power lines. Feedback evidence identified from surveys to relevant operational teams and project designers.

This role operates on a countywide basis.

The postholder is required to participate in an out of hours call out rota to respond to emergencies and winter maintenance activities.

Main Duties and Responsibilities

- 1. Undertake site surveys prior to work starting, and during works, to identify underground services hazards, and GS6 overhead power lines
- 2. Provide feedback to relevant operational teams and project designers on evidence identified from surveys
- 3. Maintain accurate records of site activities, including details on site maps/plans of utility services.
- 4. Undertake tasks to support delivery of the Winter Maintenance service, including but not limited to; installing plough attachments, loading salt onto vehicles, acting as Banksman, map reading assistance, monitoring obstructions/hazards on the highway and alert the Winter Driver to these, hand salting and snow clearance.
- 5. Participate in an out of hours call out rota to respond to emergencies and winter maintenance activities.
- 6. Work in line with all NY Highways policies and procedures and be aware of the obligations for employees under these.
- 7. Behave according to the Employee Code of Conduct and be aware of employee responsibilities under the Code.
- 8. Behave according to the Behaviours Framework.
- 9. Comply with health and safety policies, organisational statements and procedures, report any incidents / accidents / hazards and take a pro-active approach to health and safety matters in order to protect oneself and others.
- 10. Undertake any other duties of a similar nature that may be required from time-to-time.
